The transfer to a U.N. prison cell in The Hague, on June 28, 2001 of former Yugoslav president, Slobodan Milosevic, is a very important development; much more so than some people may realize. This development isn't just about right and wrong, and meting out social justice; it is about the power of money, it is about the power of the Jewish American European political machine, and it is also about giving the United Nation's ICC, or International Criminal Court, its first opportunity to exercise its full authority, while at the same time, testing the reaction of the international public to this One World Government experiment. In other words, it is another step towards the crystallization of a total One World Government, or New World Order.

The powerful individuals behind this development could not have made a better choice; they could not have selected a better target, than Slobodan Milosevic. Why? Because while he still retains popular support in his home country, public opinion against Mr. Milosevic has been carefully cultivated, via the Jewish-controlled press, in many other parts of the world. In short, bringing Slobodan Milosevic to trial is a relatively safe bet, and public opposition to this unprecedented move by the ICC will be minor.

This case is the acid test; it is setting a very important precedent; and once this precedent is set, by using Slobodan Milosevic as their guinea pig, it will also become the norm; and from hence forth, every world leader of every sovereign government will become answerable to the power and dictates of the One World Government, and its International Criminal Court, and the Jewish financial power which controls it. Do not be deceived; the German-Jewish bankers gained control of the European continent long before they did the same in the United States America. The indictment marked the first time a sitting head of state had been charged with war crimes. Milosevic and four subordinates were charged with murder, deportation and persecution in violation of the laws and customs of war.

The tribunal said Belgrade has "a binding legal obligation" to hand Milosevic over to The Hague first.

Hartmann said she expected Milosevic to be handed over for trial before the end of this year.

"It will be Milosevic in the Hague in 2001," she said.

Milosevic, 59, was removed from prison in Yugoslavia on Thursday evening and arrived at the tribunal jail at The Hague early on Friday morning.

He is the first former head of state to be transferred to The Haque for trial.

"That here we see one of the most powerful men in the Balkans today in the hands of the Hague should go to show all leaders who are bound to abuse their power that in today's world, the people in the international community demand and will ensure that impunity is not allowed to stand," U.N. Secretary-General Kofi Annan said Thursday.

Clearly then, the U.N.'s International Criminal Court, or International War Crimes Tribunal, is setting itself up as the policeman of the world, and all presidents, kings and prime ministers will be forced to adhere to its mandates, or else suffer the consequences. While none of us can deny that personal accountability is indeed a necessary factor in all of our lives, who will hold the ICC accountable for

The arrest of Slobodan Milosevic is symptomatic of the slow erosion of national sovereignty, and the strengthening of a Global Community, comprised of many faceless nations which present an illusion of freedom and democracy to their blind constituents. Behold, the husbandman waiteth for the precious fruit of the earth, and hath long patience for it, until he receive the early and latter rain." James 5:1-7, KJV

Of course, the words of the Apostle James were merely a reflection of the teachings of Jesus Himself, who taught

such things as the following concerning becoming attached to worldly materialism:

"Lay not up for yourselves treasures upon earth, where moth and rust doth corrupt, and where thieves break through and steal: But lay up for yourselves treasures in heaven, where neither moth nor rust doth corrupt, and where thieves do not break through nor steal: For where your treasure is, there will your heart be also." Matthew 6:19-21, KJV

"...Verily I say unto you, That a rich man shall hardly enter into the kingdom of heaven. And again I say unto you, It is easier for a camel to go through the eye of a needle, than for a rich man to enter into the kingdom of God."

Matthew 19:23-24, KJV

"...Children, how hard is it for them that trust in riches to enter into the kingdom of God!" Mark 10:24b, KJV

The Apostle Paul likewise taught, that rather than seeking to be rich, we should all be content with the things that we have; realizing that the love of money is truly the root of all evil, which once we are snared thereby, draws us away from our faith in God, and the things which are of true everlasting value:

"And they that use this world, as not abusing it: for the fashion of this world passeth away."

1 Corinthians 7:31, KJV

"Not that I speak in respect of want: for I have learned, in whatsoever state I am, therewith to be content." Philippians 4:11, KJV

"But godliness with contentment is great gain. For we brought nothing into this world, and it is certain we can carry nothing out. And having food and raiment let us be therewith content. But they that will be rich fall into temptation and a snare, and into many foolish and hurtful lusts, which drown men in destruction and perdition. For the love of money is the root of all evil: which while some coveted after, they have erred from the faith, and pierced themselves through with many sorrows."

1 Timothy 6:6-10, KJV

"Let your conversation be without covetousness; and be content with such things as ye have: for he hath said, I will never leave thee, nor forsake thee."
Hebrews 13:5, KJV

Finally, the Apostle John summed up the matter quite well in his first Epistle when he wrote the following admonition which precisely pinpoints the temptations to which we are each exposed:

"Love not the world, neither the things that are in the world. If any man love the world, the love of the Father is not in him. For all that is in the world, the lust of the flesh, and the lust of the eyes, and the pride of life, is not of the Father, but is of the world."

1 John 2:15-16, KJV

Because these money-minded Jewish controllers have rejected the One who established these Christian doctrines in the first place, and prefer an Earthly temporal kingdom which has been offered to them by the false god of this current world, instead of the true eternal Kingdom of the Spirit, the Bible teaches us that they have become blinded to the truth, as we see here:

"In whom the god of this world hath blinded the minds of them which believe not, lest the light of the glorious gospel of Christ, who is the image of God, should shine unto them." 2 Corinthians 4:4, KJV

Thus, in their foolish blindness, the Jews accepted Satan's bait; and ever since, they have gone about to establish their Earthly kingdom of wealth and power which, according to Biblical prophecy, will one day soon engulf all nations, as we have already begun to see.

Now, if you doubt that the arrest of Mr. Milosevic should be taken this seriously, and if you honestly do not feel that national sovereignty is really being threatened by these actions of the One World Government globalists, then please consider the fact that even though many Yugoslavs, including the new president, Vojislav Kostunica himself, were stiffly opposed to handing Milosevic over to the United Nations War Crimes Tribunal, in the end, they were forced to bow to economic blackmail, and they did as they were told to do. When he first entered office, Kostunica vehemently swore that he would never turn over one of his own countrymen to The Hague; not even Milosevic; yet it has become very clear now that, as is often the case, money speaks louder than words and noble actions. The Yugoslav economy and a Jewish-American aid package worth over one billion dollars, have been the determining factors which have resulted in Milosevic's betrayal for the proverbial thirty pieces of silver. Consider the fact that within hours of Mr. Milosevic being turned over to United Nations authorities in The Haque, the betrayal money was in fact pledged, as we see by the following excerpts taken from a June 30th CNN news report"

But the hand over brought praise from world leaders, and within hours of the extradition a donors conference in Brussels agreed to provide Yugoslavia with a \$1.28 billion aid package.

The money will be used to begin rebuilding Yugoslavia after 13 years of Milosevic's rule, international sanctions and NATO's 78-day bombing campaign in 1999.

It should be obvious to any open-minded person, that the national sovereignty of Yugoslavia has been jeopardized due to financial considerations. This issue has sharply divided the Yugoslav people. Just today I was reading an article from the New York Times, (a Jewish-controlled American publication), which reported that Prime Minister Djindjic was forced to go on national television, and weakly tell the Serb populace, in the sick style of American ex-president Bill Clinton, that as difficult as it was to arrive at the decision to turn over Milosevic, it was the morally right thing to do; because the economic viability of the young, new government, was more important than the welfare of one man. Following are a few key quotes taken from the article, which clearly reveal the heavy financial hand of American Jewry. It almost seems as if the New York Jews are boasting of their success in twisting the arm of the Yugoslav government:

Prime Minister Djindjic went on television, telling Serbs that the government had been forced to take a "difficult but morally correct" decision to protect the interests of Serbia. The government badly needs the money only the West - and particularly the United States - can offer, and Mr. Djindjic and the Yugoslav deputy prime minister, Miroljub Labus, the country's leading economist, had been the main advocates for handing over Mr. Milosevic.

"To stop the cooperation with the Hague tribunal or to postpone this cooperation would have had major negative consequences for the present and future of our country," Mr. Djindjic said.

The United States had exerted strong pressure that Mr. Milosevic, who was ousted as president in October in a popular uprising, be detained – as he eventually was on April 1 – and then delivered to The Hague tribunal.

Secretary of State Colin L. Powell spoke with Mr. Djindjic twice in the last week, and warned him that the United States was prepared to boycott a conference in Brussels today if Mr. Milosevic was not delivered to The Hague, a senior State Department official said. The new Yugoslav leaders hope to raise some \$1 billion in aid at the conference - a goal they cannot meet without American participation.

Not content with just telling the Serb people how difficult of a decision it had been to hand over Mr. Milosevic, or how it was the morally right thing to do, in typical political fashion, the Serbian Prime Minister then played on their emotions, by telling them that what had been done was for the best of the children, and future generations of Serb children. Following are some additional quotes from the same article:

Mr. Djindjic, noting that Mr. Milosevic basically called Serbs to war in his famous Kosovo speech 12 years ago, said this led only to "12 years of wars, catastrophe and ruin for our country."

The transfer decision was intended to save Serbia "not so much for ourselves and for our parents, but for our children," the prime minister said. "With this decision, we are saving the future of our children."

Let us speak honestly, shall we? Regardless of how ruthless, evil or violent Slobodan Milosevic may have been during his term in office, (and being as I am not from that country, I am not in a position to really say), the fact of the matter is that he was swept from power, and a new administration is now in place. That being the case, what threat could the man possibly pose to future generations of Serb children? Absolutely none! Primer Minister Djindjic is merely playing on popular emotions and fears, and using fanciful rhetoric, in order to try to justify the obvious weakness of the Serb government, which is clearly seen in its inability to stand against the financial czars who control the world. The truth of the matter, is that by bowing to the pressure of American Jewry, and the international organizations which they control, rather than saving the future of the children as the Prime Minister claimed in his made-for-TV speech, the political leaders of Yugoslavia have guaranteed them a future in which, like so many other nations which have been forced to place the economic noose around their necks, they will be just another subjugated puppet nation, which is obligated to comply with the whims of the Jewish-controlled One World Government; that is, if they wish to continue receiving its financial blessings.

It is for these reasons that I've stated that the transfer of Slobodan Milosevic to The Hague, in order to face the U.N. War Crimes Tribunal, is a subtle erosion of national sovereignty; and that is what these weak leaders are really giving their children. It is just an illusion of freedom and democracy. It will be freedom with an economic noose around their necks. Once they accept the trojan gift of financial aid, like so many other nations, they will be in debt, and in bondage, for life. There are no freebies with the International Jewish Bankers. Ask some of the nations of South America.

What I also find very interesting about this situation, is that, according to this same report, Mr. Kostunica, the duly-elected leader of the country, was left totally in the dark regarding Milosevic's transfer to The Hague. Now, tell me; what does this development demonstrate about the ICC's respect for national leaders, as well as the sovereign rights of nations? Following are a few additional quotes taken from the New York Times news article, which not only reveal President Kostunica's clear displeasure with the dishonest way in which his predecessor was swiftly spirited out of the country, but which also mention the fact that, in spite of the extremely negative press coverage given to Mr. Milosevic by the Jewish press in the West, at home, he

is still loved and supported by thousands, and perhaps by millions, of people:

The transfer was executed swiftly by the Serbian government without even informing Mr. Milosevic's successor as Yugoslav president, Vojislav Kostunica. On a downtown Belgrade square that had been the scene of many pro- and anti-Milosevic demonstrations through his violent 13 years of power, thousands of his supporters gathered to vent their anger.

The decision to move Mr. Milosevic sharpened the differences between Mr. Kostunica and the rest of the leaders in the multi-party alliance. Mr. Kostunica, who has criticized the Hague tribunal for anti-Serb bias, had been slow to draft a law on cooperation with it, to the point that he has been accused of jeopardizing financial aid and the international standing of the country.

Mr. Kostunica went on television later last evening to address the nation, calling it an "extremely difficult and fateful moment for our country."

He said that the problem had been "unnecessarily and unwisely created," and that the removal of Mr. Milosevic could not be considered legal or constitutional. He likened Mr. Djindjic's tactics to the "lawless and hasty acts" of the Milosevic regime and warned that the consequences were dangerous. Those indicted at The Hague deserved a chance to appeal in their own country, he said.

"Yugoslavia deserves better," he said. "Those measures endanger our country, its citizens, and also the damaged peace in our region."

Dragoslav Ognjanovic, one of Mr. Milosevic's lawyers, arrived at the Belgrade prison where his client had been held on Thursday night only to find the former leader gone. "This behavior is savage," he said.

In reading about President Kostunica's reaction to the transfer of Milosevic, which itself seems like something one would read in a spy novel, I find myself considering two possibilities. First; the president was indeed totally unaware of what was occurring, and his surprise and indignation is genuine; second; perhaps he is merely playing political mind games with the public. For all we know, perhaps he was offered the presidency in a back room deal, as well as all of the necessary foreign financial aid, which would be necessary to keep his fragile government afloat, provided that he agreed to eventually turn over Milosevic to the International Criminal Court. While reading some older CNN news reports, I came across the following very interesting paragraph from a May 3, 2001 article, which seems to add validity to this possibility. As a matter of

reference, Carla Del Ponte is the chief prosecutor for the United Nations War Crimes Tribunal. This woman has been out to get Milosevic from the beginning:

Last week, Del Ponte said she was pleased that the Yugoslav authorities had arrested Milosevic, but said the tribunal is still waiting for him to be sent to the Hague.

She said she had an understanding, but not a firm agreement, with the new Yugoslav government that Milosevic would eventually be transferred to The Hague. However, she said she did not know when that would be.

Why would Del Ponte say this, unless there was a deal in the making? If you read all of her comments in the various news reports released from April to June of this year, it is very obvious that her comments become more confident with each passing week. It seems then, that somebody was giving her the assurance that it wasn't so much a question of if Milosevic would be turned over to the U.N. War Crimes Tribunal, but rather how soon he would be turned over. In other words, it appears to have been a done deal for a number of months, and it was just a matter of waiting for the Yugoslav government to bow to the economic pressure which was being placed on it. When the Yugoslav government finally did bow, according to a June 30, 2001 CNN report, Mr. Kostunica was in fact in agreement with the transfer, and even gave his go-ahead; at least according to Serbian Prime Minister Zoran Djidjic; as we see here:

Mr. Kostunica said today that he had not been informed of the decision to transfer Mr. Milosevic to the United Nations tribunal at The Hague and rebuked members of the government alliance who suggested that he had supported the transfer.

"I never said at any D.O.S. meeting that I supported the extradition of Milosevic or any other indictee to the Hague tribunal," Mr. Kostunica said in a statement carried by Tanjug state news agency, referring to the Democratic Opposition of Serbia, the 18-party alliance that he heads.

Mr. Kostunica has opposed transfer of Yugoslav nationals to The Hague, although he had committed himself to cooperating with the tribunal.

Mr. Djindjic has said Mr. Kostunica was aware of his determination to keep his word to the international community and above all to Secretary of State Colin L. Powell. He said Mr. Powell had told him that the United States would take part in an important donor's conference for Yugoslavia on Friday, if he promised to carry out a decree issued last weekend that committed the government to sending Mr. Milosevic to The Hague.

"At this moment, I said to Kostunica, should I promise, and he said `yes,' " Mr. Djindjic said.

If Mr. Kostunica truly is appalled by what has happened, then to say the least, I would think that this incident would serve as a real wake up call for him. Now, more than ever before, I would theorize that he is suddenly realizing that there is a much greater price to pay, when one accepts the help of so-called foreign 'friends'; particularly when they happen to be the financial controllers of the world! The noose has indeed been placed around the Serbian neck, and I am not aware of any hangman who has ever been eager to remove it once it has been placed there. The Yugoslav government has sold itself to the International Jewish Bankers, and there is no escape now. Maybe the so called 'Butcher of Belgrade' is gone, but a worse monster has now taken control, and it has long arms which reach into the financial pockets of unwary nations all over the world!

Years of international sanctions and the U.S.-led air campaign devastated the country's economy and infrastructure, and Yugoslav officials hope to raise \$1.3 billion at the conference for their war-torn country.

So what really destroyed the Yugoslav economy? I will offer an answer to this question as we continue this article in part two. In addition, I will be mentioning another famous 'villain' who has likewise been the subject of American and British military assaults, as well as a target of the International Jewish Bankers. So what really destroyed the Yugoslav economy? Was it simply Milosevic's rule, or was it the international sanctions and the 78-day aerial attack on Belgrade and other major cities? Personally, I can't think of any small nation which could be subjected to such a brutal military assault and still remain unscathed in an economic sense. As I pointed out over two years ago in an article entitled ''Battle Of Gog And Magog And The War In Yuqoslavia!', there was a lot of physical destruction heaped upon Yugoslavia by the American-British forces, which would require a lot of money for the purposes of reconstruction; so I must wonder if Milosevic was added as an afterthought to the June 30, 2001 report, in order to try to pin more quilt on him, and thus make his illegal and unconstitutional arrest by the U.N. appear as a justifiable action before the world. To remind you of the devastation which was wrought against that nation by American and British forces, allow me to share with you a few quotes taken from that article, which I wrote at the time the aerial campaign was in progress:

At any rate, this war, which is again being primarily led and financed by the United States of America and its crony Great Britain, as we already know, or at least should know, is really becoming mind-boggling in scope; and is clear evidence to me that there is definitely much more going on here, than what the general public is being told on the surface. Earlier today, I read a report on the World Wide Web regarding the total number of planes, tanks, personnel, etc., which have been committed to these aerial attacks by the combined NATO forces; and it hit me really hard what a major operation this has become! Consider the following report which I just received a short time ago from CNN, the American-based Cable News Network:

NATO HITS NEW TARGETS AS US INCREASES FIRE POWER

NATO warplanes struck oil refineries, a fuel depot, bridges and a factory in pre-dawn raids over Yugoslavia Tuesday and bombed targets near the Kosovo capital of Pristina, Serbian TV reported. In Washington, Pentagon sources told CNN the United States will soon be sending in several hundred additional warplanes that will increase the size of the NATO aerial attack force to nearly 1,000 planes.

Lamentably, as we saw in part one, Yugoslavia is by no means the only nation which has felt the wrath of American-British military might, or which has been financially squeezed by the International Jewish Bankers. Please stop and consider for a moment what has also been happening for the past decade with the sovereign nation of Iraq. Serbs Feared Army Would Aid Milosevic

BELGRADE, Serbia, June 30 - Prime Minister Zoran Djindjic of Serbia said today that he had feared that the army would try to stop the transfer of Slobodan Milosevic to an international tribunal this week and that he had set up an elaborate series of ruses and decoys to spirit the former president out of the country.

He also said the police who organized the transfer were ready, if necessary, for a confrontation with the army, which is controlled by his political rival, President Vojislav Kostunica of Yugoslavia, who was against the transfer.

"We were ready to take the responsibility for the consequences," he said in an interview.

Mr. Djindjic said he worried that any delay in the transfer would have allowed time for Mr. Milosevic's supporters to rally round the prison and obstruct the transfer.

"We did not know what would be the reactions of the army," the 48- year-old prime minister said. "We had tactics to confuse. We had three cars; one went to the airport, the second to the military airport, and the third to the helicopter airport. And no one knew which car had Milosevic."

The photograph of a police van that has been seen around the world was not the vehicle containing Mr. Milosevic, he said. "The world was watching one, and it was wrong," he said.

At the airport, they had another decoy. "We knew if they were going to intervene, they would intervene at the airport," he said. "And we had, of course, one airplane coming from Montenegro, a small airplane, and all at the airport thought this was for Milosevic. But he was transferred by helicopter."

So why were part of the Serbian people and government so opposed to having Milosevic transferred to The Hague? While part of the reason has to do with the fact that the people of Yugoslavia feel that there is a strong bias against Serbs in the United Nations, the simple truth of the matter is that the Serbs obviously do not view Mr. Milosevic as being quite as guilty as he has been portrayed in the Western mass media. He is by no means innocent; but apparently they do not believe that his crimes are so great, that they warrant him being handed over to the Global Government, in order to be publicly humiliated by Carla Del Ponte; after which he will more than likely be given a life sentence.

The Western press had to paint a negative picture of Mr. Milosevic, in order to justify the recent actions taken against him. As I have explained many times before, prior to making any kind of military or political move against another nation or international figure, the government of the United States of America, (and I assume other nations as well), will implement a campaign of psychological manipulation, in order to shape public sentiment against the nation or individual which has been targeted. Movies, TV, the printed media, etc., are all used to create a dark, negative image of that nation or national leader, so that when the government finally makes its move, popular support is very high; even if that support is based upon a twisted perception of reality. The Jewish puppeteers are masters with words, and masters when it comes to destroying a person's credibility.

What you might find interesting, is the fact that the first two countries to lavish praise upon the Serbian government for its decision to hand over Mr. Milosevic to the United Nations War Crimes Tribunal, were none other than the USA, and obviously, their faithful lackey, Tony Blair of Great Britain, as we see by the following CNN news report excerpt. These two nations will grab at anything in order to justify their merciless bombing of Belgrade:

Let us return now to the strategies of the Jewish bankers. Once money lords like the IMF have weakened and destroyed a nation, then they 'compassionately' extend their false hand of friendship, which is enticingly filled with American economic aid. The underlying message appears to be, 'We will be glad to help you to rebuild your country; and we will even happily provide all of the financial aid which you require in order for your young new government to remain afloat and in power, BUT, from now on, you must agree to do things OUR way'; and that is precisely what the International Jewish Bankers have done all over the world. The third world is indebted to the American-Jewish financial czars via IMF and World Bank loans, etc., which can never be paid in full, because the interest on those loans continues to add up year after year. I am reminded of a verse I have shared a number of times before, found in the writings of the Prophet Hosea. It states:

"He is a merchant, the balances of deceit are in his hand: he loveth to oppress." Hosea 12:7, KJV

What an interesting verse, and what an interesting phrase to use; 'the balances of deceit'. You see; when these other nations make financial agreements and trade deals with the West, which is controlled by the International Jewish Bankers, they think that they are getting one thing, while in reality, they are getting something very different. What appears to be a balanced, fair deal, or a loan which will easily be paid off, is really no such thing at all. The balances are clearly tipped to the advantage of the entity which is providing the loan, and not to the favor of the receiver nation, and those nations soon find themselves living under years of financial bondage to the IMF, the World Bank, etc.; and Yugoslavia will soon find this out!

While national governments may have locally born and raised leaders, the real leaders more than likely live thousands of miles away in their ivory towers, where they plan their next financial takeover. As I point out in other articles, the Jews have been using their manipulative financial power to try to gain control of Gentile nations and empires for literally thousands of years. It may be due to this very reason, that in the Book of Acts, we are told that Emperor

Claudius ordered all of the Jews to leave Rome. Perhaps he realized the threat that they posed to the established order:

"And found a certain Jew named Aquila, born in Pontus, lately come from Italy, with his wife Priscilla; (because that Claudius had commanded all Jews to depart from Rome:) and came unto them." Acts 18:2, KJV

Down through history, the Jews have been kicked out of one country after another, because it seems that they are never content with being just guests in any country; they always seem to want to try to take it over; they have this innate craving to want to be in control. What I personally find rather interesting regarding all of this, is the fact that while the Jews do their best to control the Gentile nations of the world through crafty financial deals, the Levitical and Mosaic Law expressly forbids them to charge interest to a fellow Jew. Consider the following verses:

"If thou lend money to any of my people that is poor by thee, thou shalt not be to him as an usurer, neither shalt thou lay upon him usury." Exodus 22:25, KJV

"Thou shalt not give him thy money upon usury, nor lend him thy victuals for increase." Leviticus 25:37, KJV

"Thou shalt not lend upon usury to thy brother; usury of money, usury of victuals, usury of any thing that is lent upon usury:" Deuteronomy 23:19, KJV

Hundreds of years later, King David affirmed that God truly does bless those who do not try to take financial advantage of others when he wrote:

"He that putteth not out his money to usury, nor taketh reward against the innocent. He that doeth these things shall never be moved." Psalms 15:5, KJV

While the previous verses condemn a Jew charging interest to another Jew, as I point out in 'The International Jew And The Protocols Of Zion' series, the Babylonian Talmud, which is the true basis for modern Judaism, teaches the exact opposite regarding financial dealings with Gentiles. That blasphemous tome tells the Jews that the Gentiles were purposely created to be abused and exploited in every way possible by the Jews. Gentiles are not even viewed as being human within its pages. Again, I encourage you to read the series if you want to discover some startling revelations regarding the true Jewish mentality towards the Gentile world. If you think that anti-semitism is a crime, just wait until you learn of the hatred that Jews have towards Gentiles, and particularly towards Blacks and Christians!

Let us return to Slobodan Milosevic. By having him spirited away to The Hague, contrary to Kostunica's wishes, it seems that this has given America opportunity to stick her untamed tongue out at the rest of the world, and basically tell them 'See! Even though you did not agree with us at the time, our 78-day bombing of Belgrade was justifiable! Even the Yugoslav government in Belgrade is agreeing that we did them a favor,

by cooperating with us now, and having Slobodan Milosevic sent to the War Crimes Tribunal'. Don't be deceived, folks. As I said earlier, Mr. Milosevic is merely being used to set an all-important precedent. Regardless of the outcome of his trial, just the fact that a leader of a sovereign country is successfully being put on trial by a world body, will make it easier, and socially more acceptable, to put the next leader on trial as well. We all know that once a precedent is set in a courtroom, whether it is a city, state or federal courtroom, or in this particular case, the International Criminal Court, it is often used as a reference point, in order to add validity to, and to strengthen, future cases.

Speaking of the next cases, I have no doubt that they will occur sooner or later. Who might some of the next criminals be who will be tried by the ICC? It isn't too difficult to imagine Osama bin Laden and Saddam Hussein in this picture; provided, of course, that they can be caught; after all, they too have been painted as cold-hearted murderous thugs; and the Western world would probably not be too quick to condemn bringing both of these men to trial. Thus the subtle mental conditioning continues; the idea being, 'Take care of a few real bad boys first, so the ICC becomes socially acceptable, and then begin to exercise more authority in other more controversial matters which may conflict with national sovereignty. Before long, the whole world may find itself on trial by the One World Government. 'Either follow the mandates and policies of our New World Order, or else be prepared to pay the consequences; beginning with economic blackmail!'.

Believe me; while nations as a whole are currently being affected by the slow, insidious growth of the One World Government, eventually, its authority and influence will reach down to every single individual. "The eyes of the LORD are in every place, beholding the evil and the good." Proverbs 15:3, KJV

"For there is nothing covered, that shall not be revealed; neither hid, that shall not be known." Luke 12:2, KJV

"If I had not come and spoken unto them, they had not had sin: but now they have no cloke for their sin."

John 15:22, KJV

"Neither is there any creature that is not manifest in his sight: but all things are naked and opened unto the eyes of him with whom we have to do." Hebrews 4:13, KJV

"So then every one of us shall give account of himself to God." Romans 14:12, KJV

"For we must all appear before the judgment seat of Christ; that every one may receive the things done in his body, according to that he hath done, whether it be good or bad." 2 Corinthians 5:10, KJV

"Wherein they think it strange that ye run not with them to the same excess of riot, speaking evil of you: Who shall give account to him that is ready to judge the quick and the dead." 1 Peter 4:4-5, KJV

"And I saw a great white throne, and him that sat on it, from whose face the earth and the heaven fled away; and there was found no place for them. And I saw the dead, small and great, stand before God; and the books were opened: and another book was opened, which is the book of life: and the dead were judged out of those things which were written in the books, according to their works. And the sea gave up the dead which were in it; and death and hell delivered up the dead which were in them: and they were judged every man according to their works." Revelation 20:11-13, KJV

The primary difference here, is that I prefer to trust in God's Righteousness and Mercy, because His Law, and His Justice is perfect, while man's laws, and man's judgments are imperfect; and in fact, they are often biased due to political, economic or other selfish motivations. As King David was inspired to write:

"The law of the LORD is perfect, converting the soul: the testimony of the LORD is sure, making wise the simple...The fear of the LORD is clean, enduring for ever: the judgments of the LORD are true and righteous altogether."

Psalms 19:7, 9, KJV

"Thy word is true from the beginning: and every one of thy righteous judgments endureth for ever." Psalms 119:160, KJV

So again, with the case of Mr. Milosevic, we may be catching a glimpse of an overbearing future world government, which will control ever facet of our lives. God's Word is slowly being fulfilled, because He is the great I AM who sees the end from the beginning, and His Word never fails, as we see here:

"I know that, whatsoever God doeth, it shall be for ever: nothing can be put to it, nor any thing taken from it: and God doeth it, that men should fear before him. That which hath been is now; and that which is to be hath already been; and God requireth that which is past."

As the above quotes mention, while Mr. Milosevic defiantly sits in a U.N. jail cell pondering his upcoming trial and eventual fate, the country which betrayed him, is literally falling apart at the seams. The fragile government of Yugo-

slavia, which is comprised of representatives from the two remaining republics of Serbia and Montenegro, may be on the verge of being dissolved, as each of the republics goes their own way, as a result of the deep differences in their political ideologies. In this same news report, it states:

BERLIN, Germany -- Serbian Prime Minister Zoran Djindjic has seized on the chaos in Yugoslavia following Slobodan Milosevic's handover to a U.N. court to call for political reform.

And he raised the prospect of a "peaceful separation" of Serbia and Montenegro, the two republics which make up the Yugoslav Federation.

The federal government in Yugoslavia has collapsed after Milosevic, reported by Reuters to be on constant suicide watch in The Hague prison where he is being held after his extradition face war crimes charges.

"The Federation is in deep crisis. We need to come up with a concept for change in the constitution," Djindjic, who ordered Milosevic's extradition, told German television.

He said the alternative if Montenegro rejected reforms was separation.

Djindjic, whose decision to hand Milosevic over was opposed by Yugoslav President Vojislav Kostunica, said he thought new elections were unlikely in the immediate future.

Milosevic's extradition led to the collapse of the federal government after junior partners in the ruling DOS coalition of reformists quit in protest.

Yugoslav prime minister Zoran Zizic, who is from Montenegro, resigned his post on Friday.

Relations between Serbia and Montenegro are strained, and Zizic's walkout from the Cabinet raised fears that the move could lead to the breakup of Yugoslavia.

March 16, 2006 Postscript:

On Saturday, March 11, 2006, after a lengthy four-year war crimes trial which was about to come to an end, Slobodan Milosevic was found dead in his bed in his prison cell, which was located in The Hague.

According to the United Nations war crimes tribunal, the autopsy report indicated that the former Yugoslav leader died of a heart attack. However, only one day before his death, in a four-page letter written in Serbian, Milosevic claimed that someone was trying to poison him, because they wanted him silenced.

To add to the Milosevic controversy, various sources stated that rifampicin, an antibiotic which is used to treat serious bacterial infections, such as tuberculosis and leprosy, was found in Mr. Milosevic's blood. This drug was not prescribed by Milosevic's doctor. More importantly, it is known to reduce the effectiveness of other medications that Milosevic was taking, in order to control his high blood pressure and heart condition. Because of Milosevic's sudden and unexpected death just prior to the conclusion of his trial, rumors began to circulate that the former leader of Yugoslavia had been murdered. I seriously doubt that we, the general public, will ever know the full truth of the matter.
